

# FIREARMS USE AND RENTAL AGREEMENT

(Proponent: Recreation Division, Directorate, Morale, Welfare, and Recreation)

**PRIVACY ACT STATEMENT / AUTHORITY:** 10 U.S.C., 3013 / **PRINCIPLE PURPOSE:** To record personal information for all Military personnel, their family members, Department of Defense (DOD) civilians and non-DOD civilians who use firearms on Fort Gordon (FG) but are not required to have an approved and valid FG Form 9243, Personal Firearms and Weapons Registration. A further purpose is to provide for the efficient administration of the firearms rental operation at the Tactical Advantage Sportsman's Complex (TASC). **ROUTINE USES:** To ensure individuals declare in writing that they are not disqualified from bringing firearms onto or using firearms on the installation. The Social Security Number (SSN) is used to ensure identity and eligibility. Other personal data may be used to facilitate financial accounting and bill collection. **DISCLOSURE:** Voluntary. Personnel who do not disclose the required information will not be authorized to use firearms on FG. Personnel on the installation in possession of firearms without a valid and approved FG Form 9243 or, as applicable, a valid NAF Form 7160 in their possession or on file at the TASC could result in confiscation of their weapons, disciplinary action, denial of entry to FG, or other appropriate action.

**Shooting range guests without an approved FG Form 9243:** Complete NAF Form 7160 and file with the Tactical Advantage Sportsman's Complex (TASC). Keep one copy in your possession while participating in shooting range activities. This form will expire one year from date received by TASC unless renting a firearm or being sponsored by a different person.

**Hunting guests without an approved FG Form 9243:** Complete NAF Form 7160. Keep one copy in your possession along with the FG daily hunting license guest permit while hunting. See FG Regulation 420-5 for hunting guest policies.

**NOTE:** All sponsored guest or sponsored family members without an approved FG Form 9243 and using the shooting range or participating in hunting activities must complete this form in all applicable blocks if they are over 16 years old.

The undersigned agrees he/she will exercise reasonable care in the use of said item(s) and will return the same to the IMWRF in the same condition in which it was received from the IMWRF.
